## 1.1 RESTRICTIONS OF LOCAL FLIGHTS

## 1. Restriction of local flights within ILS Approach Area

- 1.1 In addition to the existing regulations concerning the operation of an aircraft within Mauritius Control Zone, the following restrictions are to draw the attention of pilots engaged in local flights when they operate within the ILS Approach Area.
- 1.2 To safeguard the ILS Approach to runway 14 of Sir Seewoosagur Ramgoolam International Airport, the following restrictions shall apply to flights within the airspace demarcated by points A, B, C, D, E, F, G and H as shown on page **FIMP AD 2-41**.

- 1.3 Within airspace demarcated by points A, B, G and H an aircraft shall not:-
- a. fly above an altitude of more than 3000 ft without clearance from Mauritius Air Traffic Control when operating outside the Mauritius Control Zone; and
- b. Operate inside the Control Zone without clearance from the Mauritius Air Traffic Control.
- 1.4 An aircraft shall not enter the area B, C, D, E, F and G at any altitude without clearance from the Mauritius Air Traffic Control.
