1. Scope of Contract

The Department of Civil Aviation invited proposals for **Resident Inspector for the provision of safety oversight functions in the field of Air Navigation Services (ANS)**.

The selected organisation is required to position a resident ANS inspector (specialised in the safety oversight of Air Traffic Management) in Mauritius who shall carry out safety oversight functions on behalf of the DCA and provide necessary training to a national ANS inspector upon recruitment. The resident ANS Inspector shall assist the Department to properly discharge its responsibilities and fulfil its Safety Oversight obligations as a Contracting State of ICAO

2. Procurement method used

International Open Advertising bidding through e-Procurement System was used for this procurement exercise.

3. Date of Invitation of Bids

The invitation for Bids was issued on 26 August 2021.

4. Closing date for submission of bids

The closing date for the submission of bids was 06 October 2021
